Dear Salon Owner:

Your current salon service license expires on December 31, 2020. In keeping with the requirements of CT General Statutes, CT Public Health Code and the North Central District Health Department (NCDHD) Sanitary Code, please plan to submit your renewal application and license fee (see fee schedule below) to the NCDHD on or before December 31, 2020. Salon licenses are not transferable from one business owner to another.

Please Note: The NCDHD Board of Directors voted to decrease fees by 25% for the 2021 license year as a show of support for the business challenges caused by COVID-19.

1. Salon renewal applications and license fees are due on or before December 31, 2020.

- NCDHD offices are currently closed to the public. All salon renewals must be sent through mail, fax or email to licenser renewal@ncdhd.org.
- NCDHD now accepts credit card payments by phone at 860-745-0383.
- Renewals received and/or postmarked after December 31, 2020 will be charged a late fee of \$131.25-\$225.00 (aligned with licensure fee). There will be no exceptions.

THE SALON OPERATOR AND ALL COSMETOLOGISTS AND BARBERS MUST POSSESS A CURRENT LICENSE FROM THE STATE OF CONNECTICUT. The reinspection fee for a failed inspection due to a four (4) point debit is **\$300.00**. **If you do not have a valid CT License or paid personal property taxes and/or sewer charges, you will not be able to renew your Salon License.**

- Any modifications, reconstruction or equipment changes will need prior review and approval by NCDHD.
- Should you intend to sell your business, a New Owner Inspection is required.
- Please contact our Enfield office for the correct forms and information 30 days prior to construction or a change of ownership. Our forms are also on our website at www.ncdhd.org under "Forms".

Salon inspections for 2021 will be done through the calendar year in the District. If you have any questions regarding these requirements, please contact the office at 860-745-0383 and ask to speak with Jessica Yelsits.
